## 1. Purpose:

To encourage a young research atmosphere and to reward outstanding papers in the Kaohsiung Journal of Medical Sciences (hereinafter "Kaohsiung J Med Sci"), Kaohsiung Medical University hereby establishes the Directives for Selection of Dr. Tsung-ming Tu Young Outstanding Paper Award (hereinafter "the Directives").

## 2. Selection Target:

The first author of the submitted paper is under the age of forty-five (45) at the time of submission.

## 3. Selection Process:

(1) Recommendation: Papers published in the Kaohsiung J Med Sci in the previous year are recommended by experts, and categorized into two groups based on the first author's affiliation - physicians and non-physicians. One paper per every five in each field is recommended; if less than five papers, one paper may be recommended.

(2) Preliminary Review: Papers recommended are sent to two experts for preliminary review, with the experts being determined by the chief editor of the Kaohsiung J Med Sci.

(3) Secondary Review: Papers that pass the preliminary review are reviewed by the Secondary Review Committee, selected by the Editorial Committee of the Kaohsiung J Med Sci (hereinafter "the Editorial Committee"), and submitted to the Editorial Committee for deliberation. One outstanding paper each for physicians and non-physicians is selected. If no appropriate paper is available, the selection will be omitted.

## 4. Source of Funds:

The award money is provided by the budget of the "Kaohsiung J Med Sci." After the amount of the reward is reviewed and approved by the President, the Kaohsiung J Med Sci issues the certificate and award money as an incentive.

5. After being reviewed and passed by the Academic Research Committee, Administrative Meeting, and Board of Directors Meeting, the Directives shall be implemented from the date of announcement, and the same applies to amendments.
